ARTWALK 2008 Indoor Show Instructions

Screening Process

No slides will be required for indoor show only, Artists are requested to deliver each entry for jurying on **Monday, September 22, 2008**, between 9:00 a.m. and 12:00 noon to Fleischmann Auditorium. Entries will be juried and, artists are required to return Tuesday, September 25 between 10:00 a.m. and 1:00 p.m. for selection results. Acceptance will be based on quality and originality and in comparison with other applicants. Work must be framed and wired for hanging. Giclee not accepted.

Exhibit Space

The show will be hung in Fleischmann Auditorium by the curators of the exhibit, Patti Jacquemain and Jill Vander Hoof. Special requirements should be sent in writing with your application. Pedestals and other display materials for three-dimensional work must also be provided by the artist.

Awards

First: \$500 Second: \$300 Third: \$200

Commission

A 25% commission on all sales from the indoor show will be collected.

Insurance

All exhibitors must carry adequate theft and liability insurance on their work. All Santa Barbara Museum of Natural History buildings are secured by an alarm system.

Reception

A reception will be held on Friday, September 26, 2008 to honor all artists. Artists are invited but not required to attend.

Note

All work must be for sale. No work will be juried while artist or agent is present. Artists, or agent holding your signed receipt, must retrieve unsold work after 5 p.m. Sunday, September 28, 2008. **Absolutely no pick up prior to 5 p.m. as show is still in progress.** If work sells after it is accepted to the show, the Museum League must receive commission, and artist must reach agreement with client that work can be shown during Artwalk 2008.

Outdoor Show Instructions

Screening Process

A jury will determine your eligibility based solely upon quality and originality as shown in your slides and in comparison with other applicants within your category. Space assignments will not be made until September 25, 2008.

Exhibit Space

Each exhibitor will have an approximately 10 x 10-foot space. The exhibit area is along historic Mission Creek on the grounds of the Museum. In this natural setting, spaces are not completely level and may be irregularly shaped. All equipment and materials needed for display must be provided by the artist. No electric hook-up is available. Artists must set up exhibit on **Friday, September 26 between 9:00 AM and 3:00 PM**

Artist Presence Required

Artists must personally represent their own work. Exhibitors must attend both show days. Art and display materials must remain visible and unpacked until end of show. Show hours are 10 a.m. to 5 p.m. Saturday, and Sunday. All displays must be set up by 10 a.m. each day. Demonstration of art technique is encouraged.

Commission

No commission will be charged. Only a space fee if accepted and a non-refundable jury fee.

Permit

A valid California State Seller's Permit is required and can be obtained at the State Board of Equalization in your area.

Awards

First: \$300 Second: \$200 Third: \$100 Non-cash awards

Insurance

Exhibitors are responsible for theft and liability insurance for their work. SBMNH's insurance does not cover artwork. Overnight storage in secured buildings and a guard are provided.

Please note that the League reserves the right to remove any exhibitor before or during the show in cases where:

- The League feels the exhibitor is guilty of improper conduct.
- An exhibitor attempts to sell work that is other than his/her original artwork.
- An exhibitor's work does not reflect the work that was juried.
- An exhibitor hinders or encumbers another exhibitor's display or ability to display properly
- An exhibitor moves to another location without permission.
- An exhibitor attempts to sell T-shirts
